



## Statement of Intention of Candidacy - Nonpartisan

- The S.C. Constitution prohibits a person who has been convicted of a felony from filing for public office for 15 years after the completion of the sentence, including probation and parole time, unless previously pardoned.

### Statement of Intention of Candidacy – Notice of Public Information

I understand that all information listed on the Statement of Intention of Candidacy form that I just completed is public record and will be posted on the Board of Voter Registration & Elections of Pickens County's website for public inspection: <http://pickenselections.org/>

I understand that if I don't want the public to have access to certain telephone numbers or other information, I should not list them on the form.

### Ethics Forms

I understand that I must still file a Statement of Economic Interest (SEI) Form and Campaign Disclosure Form with the State Ethics Commission on their website: <http://ethics.sc.gov/>

I understand that election officials have no requirement to ensure that either the Statement of Economic Interest form or Campaign Disclosure form has been filed with the Ethics Commission.

I understand that I will face fines for not filing these forms on time in accordance with the instructions on the Ethics Commission Website.
