

NOTICE OF SPECIAL ELECTION NOVEMBER 2, 2021

This notice is to the citizens residing inside the District Seven (7) school boundary of the County of Pickens, South Carolina. In accordance with SC Code of Laws 7-13-190, a special election shall be held on November 2, 2021, to fill the unexpired term.

Only the electors living within District Seven (7) school boundary may participate in this election.

Every person wishing to vote in this election must be registered as an elector and a resident of the municipality 30 days prior to the date of election. Any person wishing to vote in this election must register no later than Sunday, October 3, 2021. Voter Registration by Mail forms will be accepted if postmarked by Monday, October 4, 2021. To register to vote in Pickens County or update your address and/or other voter registration information:

Registered electors who cannot vote in person on the day of the election may be eligible to vote by absentee ballot. You may call 864-898-5948 to request an absentee application. Absentee ballot application requests can also be made by going to our website: <https://pickenselections.org/absentee-application-request/> or by coming in-person to the Voter Registration and Elections Office. Beginning Monday, October 4, 2021, the Pickens County Voter Registration office will be open for in-person absentee voting during regular business hours.

Registered voters will be asked to provide one of the following valid Photo IDs at their polling place.

- S.C. Driver's License
- ID Card issued by S.C. Department of Motor Vehicles
- S.C. Voter Registration Card with Photo
- Federal Military ID
- U.S. Passport

Voters without Photo ID can get one free of charge from the Department of Motor Vehicles or their county voter registration office. Public testing for voting machines will be held at the Voter Registration and Election Office on Thursday, September 30, 2021 at 10:00 a.m.

At 9:00 AM on November 1, 2021, the County Board of Voter Registration and Elections will begin its examination of the absentee outer envelope, and at 9:00 AM on November 2, 2021, will begin its examination of the inner envelopes, in the Pickens County Voter Registration & Elections Office inside the Pickens County Administration Facility located at 222 McDaniel Ave, Pickens, SC, 29671.

At 12:55 PM on November 4, 2021, the Board of Voter Registration & Elections of Pickens County serving as the County Board of Canvassers will hold a hearing to determine the validity of all provisional ballots cast in this election. This hearing will be held in the Board Room inside the Pickens County Administration Facility located at 222 McDaniel Ave, Pickens, SC, 29671.
