Board of Canvassers Meeting Minutes

Pickens County Administrative Building Conference Room

1. The Board of Canvassers Meeting was called to order at 12:55 p.m. by Chairman Jim Liddle. He welcomed everyone and thanked them for attending the meeting.
2. Present:
 - a. Jim Liddle
 - b. Cheryl Allen-Bailey
 - c. Amanda Bauknight
 - d. Brian Dismukes
 - e. James Schmutz
 - f. Dr. Amy Sams, Executive Director
 - g. Skeet Holland, Election Analyst
 - h. Sharon Rausch, Office Manager

3. All Board members took the Canvassers Oath.
4. Canvass Checklist reviewed by Dr. Sams. All applicable sections and procedures completed.
5. Dr. Sams reported 2 hand count audits were conducted: Democratic US Senate contest in Clemson precinct and Republican State Superintendent of Education contest in Pumpkintown precinct. All accounted for.
6. Board reviewed the Recommendations to NOT count the following Provisional Ballots, as follows:
 - a. 3 ballots not counted – voted in wrong precinct – motion made by Bauknight to not count these 3 votes, seconded by Dismukes, all in favor
 - b. 1 ballot did not count – moved to Pickens County from another county/not registered – motion made by Schmutz to not count this ballot, seconded by Bauknight, all in favor
7. Board reviewed Recommendations to COUNT the following Provisional Ballots, as follows:
 - a. 1 address change—motion by Liddle, 2nd by Allen-Bailey, all in favor
 - b. 1 ballot rejected by scanner—motion by Bauknight, 2nd by Allen-Bailey, all in favor
 - c. 1 name change—motion by Dismukes, 2nd by Schmutz, all in favor

- d. 1 ballot rejected by scanner—motion by Allen-Bailey, 2nd by Bauknight, all in favor
 - e. 1 ballot rejected by scanner—motion by Liddle, 2nd by Dismukes, all in favor
8. Motion to recess by Liddle at 1:16 pm. Second by Bauknight. All in favor. Board of Canvassers meeting recessed.
 9. Motion to reconvene by Liddle at 1:52 pm. Second by Dismukes. All in favor. Board of Canvassers meeting reconvened.
 10. Director Sams distributed the Official Election Results to the Board. This completed the Canvass Checklist. Board reviewed Official Election Results. Motion by Bauknight to Certify the June 2022 Primary Runoff Elections. Second by Dismukes. All were in favor.
 11. Board signed Certification of Election.
 12. Liddle made motion to adjourn at 2:30 pm. Second by Schmutz. All in favor.
